Ireland, Isle of Man (licenses issued since 1 April 1991), Italy, Japan, Jer

Ireland, Isle of Man (licenses issued since 1 April 1991), Italy, Japan, Jersey, Luxembourg,

Malta (licenses issued or renewed since 2 January 2004), Netherlands, New Zealand (except where a paper licence is presented), Norway, Portugal, Singapore, Spain, Sweden, Switzerland, United Kingdom, USA.
